NOTICE TO ALL CREDITORS AND OWNERS OF ENTERPRISES PLACED INTO LIQUIDATION

Pursuant to article 9 of the Law No. 04/L-034 on Privatisation Agency of Kosovo (PAK) and article 7 of the Annex of this law, we hereby **INFORM** you that the Liquidation of Enterprises/Assets according to the list below (in annex) has started on February 26th, 2020 and March 3rd, 2020 based on the decision of PAK Board of Directors dated December 23rd, 2019 and January 29th, 2020.

On March 15th, 2020, the Government of the Republic of Kosovo has drafted the decision no. 01/11 by which is declared "Public Health Emergency" due to global pandemics (SARS-CoV-2). Considering the situation created regarding public health risk and aiming to implement the decision of the Government of the Republic of Kosovo, PAK Board of Directors, on April 30th, 2020, has resolved to set a new deadline of 45 days for submission of proofs of claims and proofs of interest related to Enterprises/Assets placed into liquidation according to the list below (in annex).

Any person who claims to be entitled to file a claim and/or interest against these Enterprises or Assets of Enterprises (in annex) must submit the Proof of Claim and the Proof of Interest in accordance with article 7 and article 23 of the Annex of the Law No. 04/L-034 on PAK.

The persons who submitted the Proof of Claim and the Proof of Interest during the regular reception term with regard to Enterprises/Assets listed below that have been placed into liquidation, are not supposed to re-submit the Proof of Claim and the Proof of Interest.

In case that you have not submitted the Proof of Claim and the Proof of Interest during the regular reception term, then you are obliged to submit the Proof of Claim and the Proof of Interest despite the fact that you could have previously informed the Privatisation Agency of Kosovo or its predecessor.

If you fail to submit the Proof of Claim and the Proof of Interest within the deadline set below, then your claims shall be rejected as inadmissible according to article 35 of the Annex of the Law No. 04/L-034 on PAK. Failing to submit the documents to support your claim or incorrect completion of forms shall also result with rejection of your claims.

Submission of creditor claims starts on June 8th, 2020 and ends on July 23rd, 2020, at 16:00 h.

Application forms of the Proof of Claim and the Proof of Interest could be obtained at all PAK premises and should be delivered at PAK Regional Offices, on working days from 10:00 to 14:00.
