As part of the liquidation process, PSP will be engaged with the closure of liquidation cases which will allow distribution of funds to legitimate creditors, whereas "Surplus Funds", "Residue Funds" and "Temporary Funds" from the liquidation will be transferred to the Consolidated Fund of the Republic of Kosovo.
