PRIVATISATION IN KOSOVO

From around 600 socially-owned enterprises (SOEs) which are evidenced as socialy owned, the Agency has managed to privatise the vast majority of them creating one or more new private enterprises through two key methods: Spin-Off method and Liquidation method or Asset Sale method. So far, the Agency has held 59 Privatization waves and 23 asset sales of SOEs in liquidation, 406 SOEs have been included in privatization out of which 834 new enterprises have been created and tendered. Around 600 million Euros have been accumulated in the trust fund from privatisation of the above enterprises.

Local and foreign investments

Private investments through the privatization process have enabled Kosovo and its economy to create a large number of private enterprises out of social enterprises which are success stories inside and outside country. Besides the role for enhancing the value of these enterprises and creating new jobs, some of these enterprises are competing with the enterprises of developed countries.

Employees

The employeesand continue to receive sale of enterprises who are continuously receiving 20% of proceeds from the sale price. So far, the number of eligible employees is over 38 thousands, whereas, the distributed amount of proceeds is around 80 million Euros.

State budget enrichment

Since from the first transfer in the budget of the Republic of Kosovo of around 30 million Euros of residual funds from liquidation process of 65 SOEs, which took place in 2012, the primary goal of the Agency is distribution of funds to creditors of socially owned enterprises and transfer of residual funds to the budget of Kosovo.

Transparency

The Agency is demonstrating full transparency at all times in the course of organization of tenders by broadcasting bid submission and opening ceremony live in the internet in order to provide the opportunity to all interested people to watch the ceremony wherever they are.

Privatization as a method shall be closed following the announcement of wave 60 which shall take place in 2014, however, the Agency shall continue with asset sales of SOEs in liquidation according to new innovative sale methods.
