SUMMARY OF REQUEST

Liquidation Authority (hereinafter "LA") of Socially-Owned Enterprise "Ndërtimi" in Prizren established on 9 December 2013 in accordance with the authority given by the decision of the PAK Board of Directors, after passing all stages of liquidation procedure since from its establishment ascertained that SOE "Ndërtimi" in Prizren does not possess any property or asset registered under its name, and as such, it has not generated any proceeds from privatisation or sale of assets through liquidation, and consequently, it does not have any liquidation fund through which it would fulfil its liabilities to creditors.

Accordingly, pursuant to article 43 and article 44 paragraph 2 of the Annex of the Law no. 04/L-034 on Privatisation Agency of Kosovo, Liquidation Authority of SOE "Ndërtimi" hereby requests the Special Chamber of the Supreme Court of Kosovo that after review of the request to approve the Final Report of SOE "Ndërtimi" and to render a decision approving liquidation case closure against this Enterprise.

Liquidation procedure against Socially Owned Enterprise "Ndërtimi" in Prizren has commenced as per the decision of the Board of Directors of the Agency approved on 31 October 2013. The Liquidation Committee for SOE "Ndërtimi" and appointment of the members to serve within the Liquidation Authority was established on 9 December 2013 in accordance with the authority given by the aforementioned decision of the PAK Board of Directors. Decision on appointment of Liquidation Authority is presented in [Annex 4](#) of the Final Report.

A background of the chronology of liquidation process for Socially-Owned Enterprise "Ndërtimi" (in Liquidation) is presented in [Annex 3](#) of the Final Report. Pursuant to article 7 and 49 of the Annex of the Law No. 04/L-034 on Privatisation Agency of Kosovo, in the month of December 2013, Liquidation Authority has sent necessary notices for commencement of liquidation process in daily newspapers Koha Ditore, Zëri, Danas and Vjesti in Kosovo, Serbia and Montenegro. Copies of notices are presented in [Annex 5](#) of the Final Report.

Pursuant to article 19.6 of the Annex of the Law on PAK, formal notices have been submitted to relevant institutions. In addition, relevant notices have been sent to known creditors for initiation of liquidation procedure. Whereas, proof of delivery letters and copies of receipt books from PTK as proof of notice to these institutions, and notices to known creditors are summarised in [Annex 6](#).

Based on documentation received from relevant institutions, Liquidation Authority has ascertained that there were no assets of this SOE to be sold. In connection with this, LA possesses the confirmation from Municipal Assembly of Prizren (Directorate for Geodesy and Cadastre) and Kosovo Cadastral Agency presented in [Annex 8](#).

During the legal deadline for submission of creditor claims, the Liquidation Authority received 3 (three) creditor claims submitted for SOE "Ndërtimi" in Prizren. The final list of all creditor claims is shown in [Annex 9](#). However, since the enterprise does not have assets and as such did not generate any income, notices were sent to claimants regarding lack of liquidation funds to settle obligations. Said notices are attached in [Annex 10](#) to the Final Report.

The letter of the Special Chamber presented as [Annex 11](#) is attached to Final Report by LA, which confirms that no claim has been filed with the Special Chamber against SOE "Ndërtimi".

Proceeds from privatisation and liquidation asset sale are zero euro (€0), due to fact that the enterprise does not possess any asset registered under its name, while liquidation expenses have reached the amount of €1,138.38, (covered by Kosovo Budget) which include expenses of notices for inception of liquidation and other operational costs. Liquidation Funds Account as well as Petty Cash Report are included in Annex 11 and Annex 12 of the present report.

LA has also received confirmation from respective municipalities that enterprise does not have any property tax, the preceding confirmation is enclosed as Annex 13 of the Final Report.

In the meeting of PAK Board of Directors held on 25 May 2017, Board of Directors was informed with the contents of the Final Report of LA for SOE "Ndërtimi" in Prizren.



### **BRIEF HISTORICAL AND THE STATUS OF SOE "Ndërtimi", (in Liquidation)**

On 30/12/1989, the Socially-owned Enterprise "Ndërtimi" - Prizren, was registered in the Commercial Court of Gjakova with registration no. 550/89. This registration shows that establishment of SOE "Ndërtimi" came as a result of detachment of OPB "Ndërtimi" from OP Vodoprivredna Organizacija "Metohija" Prizren, Municipality of Prizren.

This SOE was not related with any entity outside of Kosovo territory. According to written statement issued by representative of SOE "Ndertimi"- Prizren, there was no transformation of SOE into Joint Stock Company or merging with some other company, it always remained SOE "Ndertimi" Prizren.

According to former director of SOE, Mr. Liman Mustafa, this SOE was not operational after the war in Kosovo (1999), whereas it was registered with provisional business number to UNMIK – 80094191 (in 2000).

Based on information received by Directorate for Geodesy and Cadastre in Prizren Municipality dated 8 February 2016, it is confirmed that there is no immovable property under the name of SOE "Ndërtimi".

Based on the letter sent by Kosovo Cadastral Agency that we have received on 7 September 2016, it is also confirmed that there is no property evidenced under the name of SOE "Ndërtimi".

There is no evidence regarding the issue of implementation of forced measures to this Socially-owned Enterprise.

Consequently, the Agency upon standard procedures for verification of the status of Socially-owned Enterprises which fall under administrative authorizations of the Agency, after reviewing the relevant status documentation, on 8 March 2013 has determined the status of this legal entity as a Socially-owned Enterprise that falls under the mandate and authorizations of the Agency in accordance with article 5.1 of the Law on PAK.
