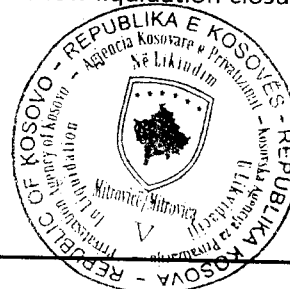
SUMMARY OF REQUEST

## EXECUTIVE SUMMARY

### SOCIALLY-OWNED ENTERPRISE SOE AC "LIKOVCI"

**Previous and current names of the enterprise:**

February 1990: entity has been Basic Organization "Likovci"

Agricultural Cooperative "Likovci" – Skenderaj, Fi 1590/90

As of 1999 AC Likovci has been registered with provisional UNMIK no. – 80057814

**Activity:** Agricultural services

**Municipality:** Skenderaj, Mitrovica Region

The decision of Agency's Board of Directors dated 17.06.2010 initiated the liquidation procedure for socially-Owned Enterprise AC "LIKOVCI" from Skenderaj. The Liquidation Committee for SOE AC "Likovci" was established on August 05, 2010 in accordance with the authority given by the aforementioned decision of PAK Board of Directors.

Pursuant to article 9 of PAK Law and article 6, 12 and 13 of the Annex to Law no. 04/L-34 on Privatisation Agency of Kosovo, on March 29, 2012 PAK Board of Directors approved the Decision to establish the Liquidation Authority. At the same time, members from PAK ranks were appointed to serve within current Liquidation Authority. Decisions to appoint previous Liquidation Committee and Liquidation Authority are presented in Annex 4 of the Final Report.

A background of the chronology of liquidation process for Socially-Owned Enterprise AC "Likovci" (in liquidation) is given in Annex 3 of Final Report. Pursuant to article 9 of the Law no. 03/L-67 on Privatisation Agency of Kosovo, article 39 of UNMIK Regulation No. 2001/6 on Business Organizations and article 43.3 (d), (e) and article 49 of UNMIK Regulation 2005/48 on Reorganization and Liquidation of Enterprises, in August 2010, Liquidation Committee sent necessary notices for inception of liquidation process in daily Koha Ditore, Kosova Sot, Vijesti and Blic with considerable edition in Kosovo, Montenegro and Serbia. Copies of notices are presented in Annex 5 in Final Report.

Whereas, formal notices to competent courts, relevant institutions regarding inception of liquidation procedure including receipts as proof of notice reception by these institutions and notices to known and potential creditors are summarized in Annex 6.

Previous liquidation committee and LA have ascertained that there were no assets of this SOE to be sold. In this light, LA possesses the confirmation of Kosovo Cadastral Agency presented as Annex 7. No claim against SOE AC "Likovci" has been submitted in due legal deadline. LA attached to Final Report the letter of Special Chamber presented as Annex 8 whereby confirming that no claim has been submitted at Special Chamber against said SOE and consequently there were no decisions issued by Liquidation Authority.

Data regarding the property of this SOE is presented in Annex 9, which shows the privatisation wave, sale price and the area of SOE included in privatisation.

AC LIKOVCI MIT006 (Fi 1590/90) in Liquidation

75% of privatisation proceeds as available funds for liquidation, after deducting 20% for workers and 5% for PAK administration fee, it reaches the value of 15,957.81 € (including the interest generated 228.81 €) whereas liquidation expenses (without court expenses) reach the amount of 2,520.65 € which include expenses of notices for liquidation inception and operational expenses. Whereas, remaining funds are identified as "surplus funds" in PAK Board of Directors meeting held in June 2012 whereby was decided these "surplus funds" be transferred into Kosovo Budget. Liquidation Funds Account and Liquidation Account Statement are included in Annex 10 and 11 herein.

LA has also received confirmation from Tax Administration of Kosovo and respective Municipality that there are not tax obligations and no property tax, which are attached to Annex 12 and Annex 13 of Final Report.

In the meeting of PAK Board of Directors of July 20, 2012, Board of Directors was informed regarding contents of Final Report of LA for SOE AC "Likovci" Skenderaj.



**BACKGROUND AND STATUS OF SOE AC “LIKOVCI”, SKENDERAJ**

## **BACKGROUND AND STATUS OF SOE AC “LIKOVCI”, Skenderaj (in Liquidation)**

Agricultural Cooperative “Likovci” was established as Basic Cooperative Organizations “Likovci” within Agricultural Organization “Produkti” in Skenderaj. This enterprise operated in the agricultural sector by producing and trading wheat, corn, different vegetables and keeping sheep.

On 23.02.1990 was issued the decision regarding separation of BCO “Likovci” from OO “Produkti” and its establishment as an independent and agricultural cooperative. On the other hand, on 19.12.1990 was held the founding assembly whereby approving and signing the contract on establishment of Agricultural Cooperative “Likovci” in Likovc. Registration of Agricultural Cooperative in Commercial Court in Prishtina took place on 01.03.1991 with decision number Fi 1590/90.

The research conducted by Commercial Court of Prishtina, the documentation of the cooperative and the research in Official Gazette of Serbia discovered no data to prove transformation of this entity into joint stock company (JSC).

On 02.06.2000, was done the preliminary registration of this legal entity in Interim Civil Administration of OUN with business number 80057814 with the name AC “Likovci” while being determined as socially-owned.

Consequently, the Agency through standard procedures to verify the status of Socially-Owned Enterprise that are under the administrative authority of the Agency, after having reviewed the relevant status documentation dated 02.11.2010, determined the status of this legal entity as Socially-Owned Enterprise which falls under the mandate and authority of the Agency in accordance with article 5.1 of the Law on Privatisation Agency of Kosovo.

During privatisation, the key and only asset of this enterprise was sold in privatisation wave 27 through Regular Spin Off. This sale included agricultural land with an area of 42ha 53ar 73m<sup>2</sup>, which is located in Likovc respectively Skenderaj Municipality.

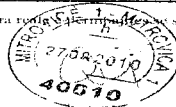



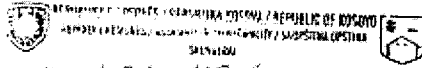
