Pursuant to article 9 of the Law no. 04/L-034 on Privatization Agency of Kosovo (PAK) and article 7 of the Annex of this law, you are hereby **INFORMED** that Liquidation of aforementioned Enterprise started on 26 Ferbuary 2020 in accordance with the Decision approved by the Board of Directors of Privatization Agency of Kosovo on 23 December 2019.

Every person pretending to have any right to claim and/or interest against the enterprise or its assets should submit the Proof of Claim and Proof of Interest in accordance with article 7 and article 23 of the Annex of the Law no. 04/L-034 on PAK.

The deadline for submission of claims begins on 6 March 2020 and ends on 23 April 2020 at 16:00 hrs.

You are invited to submit the Proof of Claim and Proof of Interest regardless of whether you may have previously informed the Privatization Agency of Kosovo or its predecessor. In accordance with article 35 of the Annex of the Law no. 04/L-034 on PAK your claim shall be rejected as inadmissible if the Proof of Claim and Proof of Interest are not submitted within the deadline. Failure to submit supporting documents to your claim or incomplete forms shall also impact in rejection of your claim.

Proof of Claim and Proof of Interest Forms may be obtained in all PAK offices and should be and should be submitted in the PAK Regional Office every business day from 10:00 hrs to 14:00 hrs in the following address:
