Name of SOE:	KBK Strezovci Kamenicë / Kamenica, Fi - 259/90 (the "Enterprise")
Name of NewCo	NewCo KBK Strezoci Administration Building and Yard L.L.C (the "NewCo")
Location	The property subject of this tender is located at village Strezovc/Strezovce 12 km from Kamenicë/Kamenica town.
Business/Sector	Agriculture.
Products	The SOE was operating as collection point of different agricultural products and as sale point of different items for agricultural needs.
Market	At present there is no agricultural cooperative operating in village, therefore farmers and different agricultural producers have the opportunity to establish modern agricultural cooperative.
Competition	At present there is no agricultural cooperative operating in village.
Workers:	There are 5 registered employees with SOE. However, none of the employees will be transferred to NewCo.
Buildings and Land	This offering will provide an excellent opportunity to acquire a land plot of approximately 2,250m ² in size, together with administrative building of approximately 160m ² suitable as collection and selling point for different agricultural products.
