Legal obligations stress the need for the privatization / liquidation promoted so as to good potential to become proper information of all stakeholders, including potential investors former potential creditors, former employees of SOEs and state and international institutions.
KPA must make announcements publications enterprises in liquidation, employee lists, procurement tenders and all other announcements that are relevant to the wider public notice.
Is a legal obligation in addition to the above publications made in local newspapers, publications are obliged to be performed in a newspaper in Serbia and a newspaper in Montenegro.
Procurement Department has signed so far contracts based on the tender announced in Serbia and Montenegro for the selection of a newspaper in Serbia and a newspaper in Montenegro to our publications interest term of one year which term has expired by 27 January 2016.
In order to continue the process towards the publication of lists of workers and the announcement of the commencement of liquidation proceedings for all enterprises and other ads that are relevant to the notice of the general public is required to connect new contracts with newspapers in Serbia and Montenegro.
he amount of the new one-year contract for Dan Graf expected to be worth up to € 205,000.00 while the contracted amount for press outreach Daily "Vijesti" in Podgorica is expected to be worth up to € 110,000.00
Negotiations have been held with the two newspapers on prices.
By Danas compared to last year we have 3% discount from the prices that we have had so far and the newspaper Vijesti we offer the discount of 4% compared to last year. (These discounts are made in deductions that last year the newspaper "Dan Graf- Danas "has after making 5% and" press Daily Vijesti "in Podgorica there were made 40%).
Prices offered by newspaper Dan Graf- Danas are 50-100% cheaper than other daily newspapers in Serbia.
Due to the correct cooperation by these two newspapers and the price much lower than other newspapers, at the request of the Department of Coordination and Liquidation is looking to continue even further with these two papers signing of new contracts with a duration of 12 months .
Last year though were signed two contracts for the same amount foreseen for 2015 or 10% of the contracts were not realized therefore for 2016 is provided for the same amount which means that contracts can be used up to the amount of mentioned but not mean to be realized in this very provided.
